I agree, if there is a dispute in connection with the use of the registered name, to accept the jurisdiction of the courts where the Registrar located. I agree that I assume sole responsibility for the registration, updating the information and use of the Domain Name. I agree that I shall indemnify and hold harmless the Registry and its directors, officers, employees, and agents from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable legal fees and expenses) arising out of or related to the Domain Name registration. I agree that the Registrant Organization and Registrar business and contractual relationship is solely between the two parties. I certify that I authorize the LBDR to publish the contact information related to the Domain Name, I accept to received notices from the LBDR via email or other means, and I agree to comply with the LBDR Domain Name Registration Policy, Privacy and Dispute Resolution Policies and Procedures as published on the LBDR official website (https://www.lbdr.org.lb/policies).
